INDICATIONS

Cleansing of eyes, prevention of eye disease (at the time such as after swimming or when dust or sweat gets into the eyes)

DOSAGE AND DIRECTIONS

Wash your eyes using 5 mL of the solution at a time, 3-6 times daily

<Pre><Pre>recautions regarding dosage and directions>

- 1. Children can use this product only under the direction and supervision of their parent or a responsible adult.
- 2. Do not use this product while wearing contact lenses. When you put on your contact lenses again, wait for about 10 to 15 minutes after washing your eyes.
- 3. Wash the cup for washing eyes well with tap water before and after use. It is recommended to allow the liquid left in the cup to dry naturally.
- 4. Do not use the product when it is clouded.
- 5. Use this product for washing eyes only.

- (4) Do not share the cup for washing eyes with others.

DIRECTIONS FOR USE

- The amount of liquid in one cup is for one eye only, not both.
- Do not wash your eye for longer than 30 seconds.
- If you wear contact lenses, be sure to take off your contact lenses before use.
- Wipe off make up or dirt around your eyes completely before use.
- Depending on the conditions of storage, white crystalize can be attached around the opening of the container. In such a case, wipe it off lightly with clean gauze.
- This product can be used by persons who are not using contact lenses.
