INDICATIONS

Arthralgia, lower back pain, bruise, sprain, muscular ache, tenosynovitis (pain of hands and wrists), elbow pain (e.g. tennis elbow), shoulder pain associated with stiff shoulder

DOSAGE AND DIRECTIONS

Apply an appropriate amount to the affected area up to 4 times a day.

- (1) Children aged 11 years or older can use this product only under the direction and supervision of their parent or a responsible adult.
- (2) Avoid contact with the eyes. If this product gets into the eye, immediately wash the eye with cold or lukewarm water. If the symptom is severe, consult an ophthalmologist.
