3. If symptoms do not improve after using this product for about 5 to 6 days, stop using this product and ask a doctor, pharmacist, or registered salesperson with this leaflet.

# **DOSAGE AND DIRECTIONS**

Apply an appropriate amount on the affected area several times a day.

- (1) Children can use this product only under the direction and supervision of their parent or a responsible adult.

- (2) Avoid contact with the eyes. If this product gets into the eye, immediately wash the eye with cold or lukewarm water. If the symptom is severe, consult an ophthalmologist.
- (3) For external use only.
- Avoid use of this product on the same area in combination with other external preparations.
- Do not use this product while the affected area and around the area are dirty.
