Precautions for use

What you should Not do:

(If you do not follow the precautions listed below, your current symptoms may worsen and you may be at an increased risk of side effects.)

1. Do not use this medicine to the following areas.
 - (1) Eyes, around eyes, mucosa (for example, oral cavity, nasal cavity, and vagina), scrotum, vulva, etc.
 - (2) Eczema
 - (3) Affected area with severe moistening, erosion, cracking, or trauma

Who should seek consultation

1. The following persons should consult a doctor, pharmacist or registered salesperson before using this product:
 - (1) Persons under treatment by a doctor
 - (2) Infants
 - (3) Persons who have experienced allergic symptoms to medicines
 - (4) Persons whose affected area is on the face or large
 - (5) Persons with affected area with pus formation
 - (6) Persons with affected area that is not clear whether it is an "eczema" or "foot ringworm, tinea cruris, tinea corporis" (If persons have symptoms of itching or erosions at the scrotum, it is often due to other causes such as eczema)
2. Stop using this medicine immediately and ask a doctor, pharmacist, or registered salesperson with this leaflet if the following symptoms appear because they may be side effects of the medicine.

Affected area	Symptoms
Skin	Rash/redness, itching, irritated skin, swelling, feeling of stimulation

3. If symptoms do not improve after using this medicine for about 2 weeks, stop using this medicine and ask a doctor, pharmacist, or registered salesperson with this leaflet.

INDICATIONS

Athlete's foot (foot ringworm), tinea cruris, tinea corporis

DOSAGE AND DIRECTIONS

Apply the appropriate amount on the affected area once daily.

<Precautions regarding dosage and directions>

- (1) Do not use this product while the affected area and around the area are dirty

- (2) Avoid contact with the eyes. If this medicine gets into the eye, immediately wash the eye with cold or lukewarm water and consult an ophthalmologist immediately.
- (3) Children can use this product only under the direction and supervision of their parent.
- (4) For external use only.

OTHER PRECAUTIONS

- Although this product seems like white cream, it is white gel containing a lot of powder which is carefully formulated to be quick drying and non-sticky.
- Wash away white gel remaining on the hands with water or soap.

INGREDIENTS AND CONTENTS

In 100 g

Ingredients	Contents	Actions
Oxiconazole nitrate	1g	Disinfects trichophyton and induces curing of the affected area
Lidocaine	2g	Relieves itching with foot ringworm and tinea
Glycyrrhetinate	0.5g	Relieves inflammation
l-menthol	1g	Gives cool sensation and reduces itching

As inactive ingredients, this medicine contains carboxy vinyl polymer, corn starch, titanium oxide, talc, BHT, dipropylene glycol, and ethanol.

PRECAUTIONS FOR STORAGE AND HANDLING

- (1) Keep the cap tightly closed and store in a dry and cool place away from direct sunlight.
- (2) Keep out of the reach of children.
- (3) Do not transfer this medicine to another container (it may cause improper use or loss of quality).
- (4) Keep this product away from flame (it contains ethanol).
